# TERMS & CONDITIONS FOR ADMISSION

## VALIDITY & LEGALITY

The school is referred to as TALK International or TALK herein. These terms and conditions supersede all previous agreements, terms and conditions, and are subject to the law of the State of Florida. Only this English version is legally binding.

## HOW TO APPLY

Students may apply in person, through a TALK Representative or through the TALK website. All family members (their parent or legal guardian if under the age of 18) must sign this Application for Admission and submit a non-refundable Application Fee of US \$150.00 per person.

## APPLICATION CONFIRMATION & PAYMENT

TALK will send written Application acknowledgement, Course Confirmation and Invoice, within three working days of receiving the Application for Admission and Application Fee. In the unlikely event that TALK does not accept the application, all monies paid will be refunded in full.

The invoice must be paid no less than 45 days prior to the course start date. Fees are calculated in complete weeks and part of a week is counted as a full week.

## METHODS OF PAYMENT

Application Fee and course fees can be paid in one of four ways:

1. Through our local representative
2. By international credit card: (American Express, Visa or MasterCard).
3. By direct transfer from your bank to ours, to: TALK International, c/o Wells Fargo Bank, Galleria Branch, Fort Lauderdale, FL 33304 – USA Account Number 20 000 256 225 13 Swift Number WFBUS6S (for International use only)
4. By check (in US Dollars and drawn on a US bank), or by International Money Order or Traveler's Check. In the case of a returned check, an additional \$50 processing fee will be incurred and only credit card or bank check will be accepted.

## LESSONS

Each lesson equals 45 minutes. Typically breaks are taken after 2 consecutive lessons.

## CLASS SCHEDULES

Class schedules are subject to change, and classes may be modified or cancelled depending on enrollment.

## REFUND DUE DATES

If refund is due, it will be made within 45 days of the date of receipt of written cancellation notice.

## CANCELLATION POLICY

1. If TALK cancels a program subsequent to a student's enrollment, TALK will refund all monies paid by the student.
2. Cancellation Prior to the Start of Class or No Show: TALK will refund all monies paid, less any actual housing costs incurred by TALK and a maximum total of \$500 identified non-refundable charges per family member including any application/registration fee, courier fees, and travel insurance, if such charges are clearly noted in the enrollment agreement as being non-refundable.

## BOOKING CHANGES (PRIOR TO START DATE)

Once TALK sends the Course Confirmation, if the family requests changes in the booking, which may include one or more changes in airport transfers, course dates, accommodation, program type, etc., TALK will charge a \$100 booking change fee. The booking change fee is payable at the time each request is made. TALK International is not obliged to fulfill any change request. All changes are at the discretion of TALK and require written approval from TALK.

## WITHDRAWAL OR TERMINATION AFTER START

TALK will not make any refunds to families after start of program.

## EXTENSIONS

Families who extend their program will be subject to the pricing and refund policies in place at the time of their extension request, as if it were a new application for enrolment.

## INSURANCE

TALK International requires students to have insurance in case of medical emergency. TALK is able to provide a policy that complies with these requirements however it is student's responsibility to evaluate the policy as TALK has no expertise in this area. TALK will arrange a travel insurance policy for students only if the request is received in writing with the Application Form and the non-refundable payment is received in full prior to commencement of classes.

## SCHOOL RULES

TALK publishes School Rules and Regulations to maintain high standards in its programs. All students are obligated to accept and comply with these rules and regulations and with all appropriate federal and state laws. Failure to comply with any of these rules may result in termination of the program and/or withholding of course certificates.

## PROMOTIONAL ACTIVITY

TALK (and its representatives) may arrange to photograph, record or shoot video footage of students for promotional purposes, (print and digital media). Any student who does not wish to participate should advise TALK at the time of booking and state at the time of the photographing or video shooting the wish not to participate. By accepting these terms and conditions the student (and their parent/guardian if under 18) gives consent to the use of these photographs or video footage without further consent or notification.

## CLASS

In the event that a group class has less than 4 students, TALK, at its option, and with the students' consent, may convert 3 group classes to 1 semi-private class (2 or 3 students) or 4 group classes to 1 private session.

## LIABILITY

TALK (and its representatives) shall not be liable in the event where third parties including but not limited to hotels, airport transfer companies, and TALK subsidiaries do not provide the services and are guilty of any criminal or civil wrong doing unless such liability is imposed on TALK by statute.

TALK (and its representatives) shall not be liable for any loss, damage, illness or injury to persons or property however caused, except where such liability is imposed by statute.
